The Montgomery County Common Pleas Court, General Division ("Court"), pursuant to the authority of Ohio Revised Code Section 2303.201(E), upon proper motion and majority approval of the Judges present at the Judges' Meeting on June 20, 2024, hereby **ORDERS** as follows:


Pursuant to Ohio Revised Code 2303.201(E), the Court has determined that, for the efficient operation of the Court, additional funds are necessary to pay for the mediation services provided by the Court.

Accordingly, the Court authorizes and directs the Montgomery County Clerk of Courts to charge an additional fee, over and above court costs, of forty-five dollars (\$45.00) on the filing of each criminal cause, civil action or proceeding, or judgment by confession to be used for such purposes.

All fees collected by the Montgomery County Clerk of Courts pursuant to this Administrative Order shall be paid to the Montgomery County Treasurer for placement in the fund designated by the Montgomery County Office of Management and Budget as the CPC General Division-Mediation Fund ("Mediation Fund"). Monies in the Mediation Fund shall be disbursed only upon an order of the Court, subject to an appropriation by the Montgomery County Board of County Commissioners, in an amount not greater than the actual cost to the Court.

By this Administrative Order, the Court hereby rescinds any and all other previous orders issued by the Court regarding the establishment of this fund for this or similarly related purposes.

ADMINISTRATIVE ORDER

The Montgomery County Common Pleas Court, General Division ("Court"), pursuant to the authority of Ohio Revised Code Section 2303.201(E), upon proper motion and majority approval of the Judges present at the Judges' Meeting on June 20, 2024, hereby **ORDERS** as follows:

Pursuant to R.C. 2303.201(E), the Court has determined that, for the efficient operation of the Court, additional funds are necessary to pay for the employment and training of the Court's magistrates and related support staff.

Accordingly, the Court authorizes and directs the Montgomery County Clerk of Courts to charge an additional fee, over and above court costs, of thirty dollars (\$30.00) on the filing of each criminal cause, civil action or proceeding, or judgment by confession to be used for such purposes.

All fees collected by the Montgomery County Clerk of Courts pursuant to this Administrative Order shall be paid to the Montgomery County Treasurer for placement in the fund designated by the Montgomery County Office of Management and Budget as the CPC General Division-Magistrate Fund ("Magistrate Fund"). Monies in the Magistrate Fund shall be disbursed only upon an order of the Court, subject to an appropriation by the Montgomery County Board of County Commissioners, in an amount not greater than the actual cost to the Court.

By this Administrative Order, the Court hereby rescinds any and all other previous orders issued by the Court regarding the establishment of this fund for this or similarly related purposes.



Accordingly, the Court authorizes and directs the Montgomery County Clerk of Courts to charge an additional fee, over and above court costs, of thirty-five dollars (\$35.00) on the filing of each criminal cause, civil action or proceeding, or judgment by confession to be used for such purposes.

All fees collected by the Montgomery County Clerk of Courts pursuant to this Administrative Order shall be paid to the Montgomery County Treasurer for placement in the fund designated by the Montgomery County Office of Management and Budget as the CPC General Division-e-Filing Fund ("e-Filing Fund"). Monies in the e-Filing Fund shall be disbursed only upon an order of the Court, subject to an appropriation by the Montgomery County Board of County Commissioners, in an amount not greater than the actual cost to the Court.



Accordingly, the Court hereby authorizes and directs the Montgomery County Clerk of Courts to charge an additional fee, over and above court costs, of fifty dollars (\$50.00) on the filing of each civil action or proceeding to be used for such purposes.

All fees collected by the Montgomery County Clerk of Courts pursuant to this Administrative Order shall be paid to the Montgomery County Treasurer for placement in the fund designated by the Montgomery County Office of Management and Budget as the CPC General Division-Technology Fund ("Technology Fund"). Monies in the Technology Fund shall be disbursed only upon an order of the Court, subject to an appropriation by the Montgomery County Board of County Commissioners, in an amount not greater than the actual cost to the Court.

ADMINISTRATIVE ORDER

The Montgomery County Common Pleas Court, General Division ("Court"), pursuant to the authority of Ohio Revised Code Section 2303.201(A), upon proper motion and majority approval of the Judges present at the Judges' Meeting on June 20, 2024, hereby **ORDERS** as follows:


Pursuant to Ohio Revised Code 2303.201(A), the Court has determined that, for the efficient operation of the Court, additional funds are required to make available computerized legal research services to the Court.

Accordingly, the Court authorizes and directs the Montgomery County Clerk of Courts to charge an additional fee, over and above court costs, of six dollars (\$6.00) on the filing of each cause of action or appeal under divisions (A), (Q), and (U) of R.C. 2302.20 to be used for such purposes.

All fees collected by the Montgomery County Clerk of Courts pursuant to this Administrative Order shall be paid to the Montgomery County Treasurer for placement in the fund designated by the Montgomery County Office of Management and Budget as the CPC General Division-Legal Research Fund ("Legal Research Fund"). Monies in the CPC General Division-Legal Research Fund shall be disbursed only upon an order of the Court, subject to an appropriation by the Montgomery County Board of County Commissioners, in an amount not greater than the actual cost to the Court.

By this Administrative Order, the Court hereby rescinds any and all other previous orders issued by the Court regarding the establishment of this fund for this or similarly related purposes.
